CONSTITUTION
A.S. COLLEGE ALUMNI ASSOCIATION KHANNA

1. NAME OF THE ASSOCIATION

The name of the Association shall be A.S. College Alumni Association Khanna.

2. HEAD OFFICE

The Head Office of the Association shall be A.S. College, KHANNA-141402.

3. AIMS AND OBJECTIVES

The aims and objectives of the Association shall be :-

- i) To further and foster the spirit of affection, brotherhood and comradeship amongst the alumni of the college.
- ii) To nurture and enhance the interests of A.S. College Khanna, in general.
- iii) To collect donations and mobilise funds to finance the projects and schemes in the college, approved by the Association.
- iv) To arrange social, cultural and sports functions.
- v) To publish books, papers, journals, news bulletins etc for the fulfilment of the aims of the Association.
- vi) To provide a forum for the alumni of the college for exchange of ideas and views on educational, cultural and academic issues of the day.
- vii) To look after the interests of the alumni of the college.
- viii) To help brilliant and needy students of the college in their academic/career pursuits.
- ix) To do all other acts in furtherance of the aims and objectives of the Association.
- x) To open branches of the Association in other towns, including towns in foreign countries.

4. MEMBERSHIP

The following categories of persons shall be entitled to be enrolled as members of the Association.

- i) Persons who have been students of A.S. College Khanna for at least one year and appeared in the annual exams, provided that they must have left the college at least five years back .
- ii) Persons who are or have been on the teaching staff of the college.
- iii) Persons who are or have been members of the Managing Committee of A.S. High School Khanna Trust & Management Society , Khanna.
- iv) The governing body may accept any other person as a member as a special case.

SUBSCRIPTION FOR MEMBERSHIP. Rs. 200/- payable in one instalment. The governing body may request the members from time to time to make such subscription , as it may decide , for furtherance of the aims and objectives of the Association.

5. PATRONS

Any person who has excelled in his field of work and is eligible to become a member of the Association may be adopted as patron of the Association. The patron shall occupy a position of eminence in the Association and will be looked upon as a friend, guide and philosopher of the Association. The Association shall seek his blessings and advice from time to time. The following shall be the founding patrons of the Association :
